

**CALL FOR CANDIDATE NOMINATIONS FOR ELECTION TO THE BOARD OF DIRECTORS  
CENTRAL VALLEY DAIRY REPRESENTATIVE MONITORING PROGRAM**

September 15, 2023

The Central Valley Dairy Representative Monitoring Program (CVDRMP, more information available at [www.CVDRMP.org](http://www.CVDRMP.org)) seeks nominations for candidates for election to its Board of Directors. The election will be held by mail-in ballot in December 2023.

One seat is available for election in your District and one seat is available at-large. Director terms are two years and begin in 2024.

Only CVDRMP voting members (defined below<sup>1</sup>) may submit nominations. A voting member may nominate himself/herself or any other voting CVDRMP member as a candidate within a given district. Each voting member may designate only one person to vote on its behalf.

All nominations must be received at the CVDRMP office no later than October 25, 2023. Nominations may be mailed to P.O. Box 227, Sacramento, CA 95812, or emailed to [cvdrrmp@gmail.com](mailto:cvdrrmp@gmail.com). Nominations received after the October 25, 2023 deadline will not be considered, even if postmarked before the deadline.

*Definition of Voting Member: Any dairy facility within the Central Valley Region as defined in section 13200(g) of the California Water Code that seeks to comply with the requirements of Revised Monitoring Program Order No. R5-2013-0122 Attachment A through the Representative Monitoring Program administered by the CVDRMP, or any other dairy facility or confined animal bovine facility within the Central Valley Region that otherwise seeks to comply with any other properly adopted Order of the Central Valley Regional Water Quality Control Board through the Representative Monitoring Program administered by the CVDRMP, shall be eligible for voting membership in the CVDRMP. Where the facility operator and facility landowner are two separate entities (collectively known as the "member facility"), the member facility is entitled to one voting membership with one vote.*

A total of seven seats are available for nominations: one for each "B" seat listed below and an additional vacant "A" seat in District 5 to complete the 2023-25 term (you may nominate only for your district seat and for the one at-large seat). All terms for "B" seats are for 2024-26.
